**CORPORATE OWNERSHIP STATEMENT OF THE ROYAL BANK OF SCOTLAND
PLC PURSUANT TO FED. R. BANKR. P. 1010(b) AND 7007.1**

Pursuant to Rules 1007(a) and 7007.1 of the Federal Rules of Bankruptcy Procedure, The Royal Bank of Scotland plc, a public limited company registered in Scotland, hereby represents that it is wholly owned by The Royal Bank of Scotland Group plc, a public limited company registered in Scotland that is publicly traded on the New York Stock Exchange (symbol: RBS) and the London Stock Exchange (symbol: RBS) ("RBS"). As of the end of financial year 2009, the total economic ownership of the United Kingdom Government, held by UK Financial Investments Limited on its behalf, including its holding in B Shares, is 83.18% of RBS, with the United Kingdom Government holding 68.4% of the ordinary shares of RBS. UK Financial Investments Limited is wholly owned by Her Majesty's Treasury, a governmental unit of the United Kingdom.
